AGENDA ITEM NO. 2: Discussion, consideration, and possible action to award a contract for professional engineering services to H.W. Lochner, Inc., with a provision to negotiate fees on a project by project basis based on a pre-established rate schedule.

Airport Manager Bonnie Wilson stated that Federal Aviation Administration (FAA) Airport Improvement Program (AIP) grant funds may be used to address engineering cost if a qualifications-based selection process is used. She stated firms selected in this manor may be contracted for up to five (5) years to support AIP funded projects. The review committee recommended to award a contract to H.W. Lochner, Inc. for Professional Engineering Services.

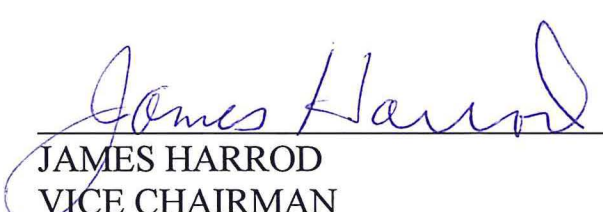
