AGENDA ITEM NO. 2: Discussion and possible action of refinancing Oklahoma Water Resources Board (OWRB) Loan No. ORF-09-0037-DW.

Mr. John Waldo and Mr. Chris Gander of Oppenheim, Inc. and Mr. Allan Brooks from Oklahoma Public Finance Law Group were present to provide information regarding the refinancing of the Series 2010 DWSRF note. Mr. Gander explained the savings advantages of refinancing and noted that B.B. & T.

has provided a proposal which will save the City approximately \$254,061.93, which is approximately double the debt service savings of the OWRB options.

It was stressed to the Trustees that if they are in favor of this proposal, six Trustees need to be present and vote in the affirmative at the June 6' 2016 Shawnee Municipal Authority meeting. All Trustees were encouraged to ask questions for a better understanding of the refinancing options to ensure an affirmative vote on June 6th.
