1. The addition of two stop signs on Kennedy Street at Norwesco Road intersection.
2. The addition of a stop sign ahead sign approximately 600' south of the Kennedy Street and Norwesco Road intersection.

Motion was made by Randy Kamm, seconded by Steve Reese, to approve the consideration of request for additional stop signs at the intersection of Kennedy Street and Norwesco Road. Motion carried 6-0.

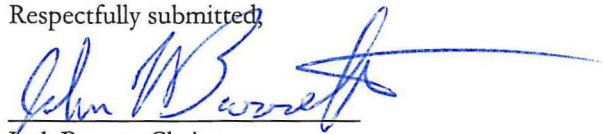
Commissioner Peltier thanked Commissioner Steve Reese for joining.

VI. ADJORNMENT

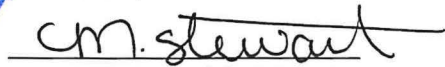
