Subject: **Staff Report** - Consideration of a request to paint a mural at Jefferson Elementary located at 205 W Dill Street, Shawnee, Oklahoma.
Case No.: **SACC 01-25** | Applicant: Shawnee Public Schools

Background

The subject property is located at 205 W Dill Street. The request is to paint a mural on the southwest side of the building, which would be facing Kickapoo Street. The applicant is requesting permission to install a mural on the exterior wall that would be 22 feet x 98 feet

The subject property is home to Jefferson Elementary School. The proposed mural is one of multiple art projects proposed at various buildings across the district. The school district has proposed utilizing a local artist, as noted in the narrative outlining their proposal. The upkeep of the mural will be the responsibility of the applicant.

Discussion

Referencing the City of Shawnee Municipal Code (Code) Section 22-750(b). Review by the Shawnee Arts & Culture Commission. “(b) *All artwork visible from a public street, on public or private property, either as a project commissioned independently by a property owner or under the auspices of this ordinance.*”

Since this proposed project is privately funded and on private property, the Shawnee Arts & Culture Commission is the deciding body; a recommendation to the City Commission is not required.

Options:

- Approval of Case No. SACC01-25, to paint the proposed mural on the southwest wall of the building at 205 W Dill Street (with or without specific conditions).
- Denial of the application for SACC01-25, thus preventing the painting of the proposed mural.
- Deferral of Case No. SACC01-25 with a request for additional and specific information to a certain date.

Recommendation: Approval of the item as presented.

Project Overview

Shawnee Public Schools respectfully submits this proposal for the approval and support of a mural installation on the southwest wall of Jefferson Elementary School. This wall, measuring 22 feet in height and 96 feet in width, faces Kickapoo Street and offers a prominent and highly visible space for public art.

Project Description

The proposed mural will be designed and executed by local artist Nicholas Blanchard, whose recent works, including the Jim Thorpe mural at Jim Thorpe Stadium, have garnered significant community acclaim. The artwork will feature:

- **Thomas Jefferson:** As a tribute to the namesake of the school, the mural will prominently depict Thomas Jefferson.
- **Education Themes:** Surrounding Jefferson will be imagery related to education, representing growth, learning, and community values.
- **Color Palette:** Muted tones will be used to create a timeless aesthetic that blends seamlessly with the architectural style of the building.

The mural will utilize most of the available wall space, creating an engaging visual experience for students, staff, and the community.

Purpose and Vision

This project is part of a larger initiative to install murals at each elementary school site across the district. By integrating art into our schools, Shawnee Public Schools aims to:

1. **Enhance Community Engagement:** Promote a sense of pride and identity within the neighborhood and the city.
 2. **Celebrate Education:** Highlight the importance of education through thoughtful, inspiring imagery.
 3. **Support Local Artists:** Provide opportunities for artists like Nicholas Blanchard to contribute their talents to the community.

Maintenance and Preservation

Shawnee Public Schools is committed to ensuring the longevity and vibrancy of the mural. The district will:

- **Conduct Regular Inspections:** The mural will be inspected by district facilities staff to assess its condition and identify any necessary maintenance.
 - Should the mural require touch-ups or repairs, Shawnee Public Schools will engage professional artists, including the original artist when available, to preserve the integrity of the artwork.
