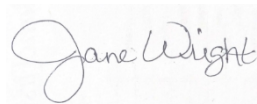

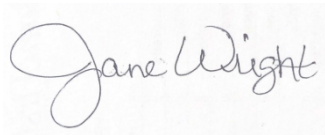
Mr. Ward informed staff and board members that he knows a local person who would be willing to come and help seniors set up phones and computers with cybersecurity software.
