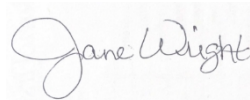

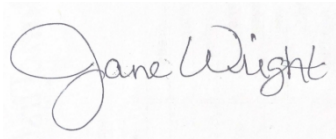
Committee members discussed the IFYR coming up in July and the Independence Day Parade.
