AGENDA NO 7 Discussion of Progress on Board Goals and Objectives

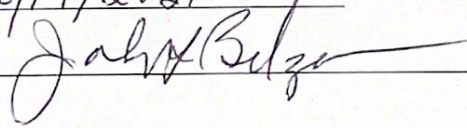
Albert Rice gave information that we will be given to to call. There will be a Script to use.
