**III. CONSIDERATION OF REQUEST BY DELBERT TOTTY TO CLOSE THE
CENTER MEDIAN ON KICKAPOO AND POPLAR**

Discussion:

Staff recommends denial of request by Delbert Totty to close the center median on Kickapoo and Poplar.

Michael Ludi presented a power point presentation showing the location on Kickapoo. The power point showed the existing traffic flow and also what the traffic flow would look like if the City did close the median. Also the presentation showed the proposed Oklahoma Department of Transportation (ODOT) future plans to alter the median opening to function better, with acceleration and deceleration lanes.

Michael Ludi also stated that the reasons for denial is that Domino was required to improve Poplar St. to accommodate the traffic from North bound Kickapoo traffic turning on to Poplar and using their southern entrances. The closure would force all East bound traffic on Poplar to turn South and could lead to an increase in traffic making U-turns at the top of the hill on Kickapoo at the end of the median. The strip mall on the east side of the intersection relies on the median opening to allow south bound Kickapoo traffic to turn into

their parking lot with the median closed it would lead to their customers making U-turns at the end of the median.

Motion was made by Rueben Peltier, Second by Travis Flood to deny the request to close the center median on Kickapoo and Poplar. Motion carried 4-0
